Dear Class of 2018 and Class of 2019,

Congratulations! Third and Fourth Academic students are extended the privilege of parking on Stone Ridge's campus. Please note that we have a limited number of parking spaces available for students and that priority will be given to Fourth Academics. If you would like to park on campus, please note the following:

1. Students are required to have a valid driver's license at the time of submitting their Parking Registration Form. Parking tags and spaces cannot be reserved for the future.
2. Students need to re-apply for parking each school year.
3. Students should review the Student Parking Guidelines with their parents.
4. Students must complete the Parking Registration Form in its entirety.

Please note: Fourth Academics may begin to register for parking on Monday August 21 and Tuesday August 22 from 2:00 – 3:30pm on both days. Parking registration then becomes first-come, first-serve for both Third and Fourth Academic students starting on Thursday August 24, 2017 from 2:00-3:30pm. Third Academics may not register for parking before Thursday August 24. If spots remain, parking registration will continue on Monday August 28.

Please bring your completed Parking Registration Form, a copy of your driver's license, and the \$100 parking fee to Ms. Nuter in 183F in Good Hall.

STUDENT PARKING GUIDELINES

1. Student parking on the Stone Ridge Campus is a privilege extended to Third and Fourth Academic students only.
2. All student vehicles parked on Stone Ridge's campus must be registered with the school and display a current Stone Ridge Student Parking Tag. New vehicles and license plate numbers must be immediately reported to the Dean of Students' Office.
3. All drivers must be licensed and covered by insurance. Stone Ridge is not responsible for the vehicle or its contents.
4. Student parking is strictly limited to the un-numbered spaces (marked "S") in the "Student Parking" section of the parking lot. Vehicles should not be double-parked, parked in "No Parking" zones, "Fire Lanes," "Visitor" spaces, along the curb or elsewhere in the Cedar Lane Lot or parked in the Hamilton House Visitor Parking Lot.
5. Pedestrians are given the right-of-way on campus at all times.
6. The speed limit on campus is 10 miles per hour. Failing to abide by the speed limit, or participating in any form of reckless driving on campus, may result in the revocation of the parking permit and privilege.
7. A student vehicle may be subject to search if reasonable grounds exist to believe that drugs, alcohol, stolen property, or other contraband may be present in the vehicle while parked on campus.
8. Students may not visit the parking lot during school hours without the permission of the Dean of Students.
9. All persons involved in any type of on-campus motor vehicle accident must immediately report the accident to the Dean of Students. If any bodily injury is involved or the accident is a hit and run resulting in vehicle damage, the Montgomery County Police must also be notified.

Stone Ridge School parking regulations are strictly enforced. Disciplinary action including possible revocation of parking privileges and/or towing of vehicle, at the owner's expense, may result when violations of these regulations occur.
